DETAILS OF PAN CARD IN CANTEEN SMART CARD APPLICATION

1. Refer CS Dte letter No 95350/Q/DDGCS/Policy dated 11 April 2018.

3. Henceforth, it is mandatory to include PAN card details in canteen smart card applications. M/s SCPL will include PAN card details in the new application forms. In older application forms, the PAN card details will be filled in separately by URCs before accepting the forms.

3. PAN card details will also be included in the software patch for AFD-I items by M/s SCPL. PAN card will be physically verified prior to entry in application forms and software for AFD-I items.



**CLARIFICATION: LIQUOR ENTITLEMENT**

1. Refer CS Dte letter No 95350/Q/DDGCS/LIQ POLICY dated 18 Feb 2019 and CS Dte letter No 95350/Q/DDGCS/Policy dated 01 June 2018.
2. The following issues with respect to liquor demand/ sale by URCs are once again being reiterated:-
  - (a) 10% Additional Liquor Demand by URCs. The 10% additional authorisation, over and above URC entitlement has been done away with vide CS Dte letter No 95350/Q/DDGCS/LIQ Policy dated 18 February 2019.
  - (b) Two Month Liquor Quota. As liquor demands are based on server generated certificate, the leeway to provide two months quota to individuals proceeding on leave or to ESM no longer exists. Henceforth, no individual(Serving/Retired) will be given two month liquor quota. Serving individuals going on leave can take liquor from any URC and hence there is no need for issue of one month advance quota.
  - (c) Demand will be strictly as per server generated dependency certificate. Previous month BBF stock will be adjusted against the monthly demand.
  - (d) URCs will strictly ensure liquor demanded and collected is as per preference of beneficiaries. This will reduce dead stock/ BBF at URCs.
  - (e) Distribution of Ex- servicemen (ESM) to various URCs based on preference exercised by ESM will be ensured. Station HQ will maintain a register and issue letter of dependency to the beneficiaries. ESMs may approach Station HQ for any change in their dependency or when their stay is likely to be longer, can even shift their dependency to another station.

3. Para 3(g) of CS Dte letter No 95350/Q/DDGCS/Policy dated 01 June 2018 is hereby superseded.


