Naval Regimental System (NRS)

1. The Naval Regimental System (NRS) has been functional since Dec 10 to provide support to spouse/ NoK/ dependents after the demise of naval personnel irrespective of the time of the incident i.e. whether it occurred whilst in harness or after retirement. NRS has now emerged as a platform where issues pertaining to widows/NOK are being dealt with in a speedy manner. Command Regimental System Officers (CRSO) have been appointed at Command Headquarters. To cover the areas that are not in immediate vicinity of Command Headquarters, additional officers have been appointed as CRSOs. Details of CRSOs as per the geographical responsibility are given below:-

DESA Updates

2. Jeevan Pramaan/ Digital Life Certificate Services at the Doorstep of the Pensioners through India Post Payment Bank (IPPB). India Post Payments Bank (IPPB) has established a national network more than 1,36,000 access points in Post Offices and more than 1,89,000 Postman & Gramin Dak Sevaks with smartphones and biometric devices

to provide doorstep banking services. Postmen and Gramin Dak Sevaks can generate Jeevan Pramaan/ Digital Life certificate at the doorstep. Dept of Posts letter D.O No. 5-4/2019-PBI dated 04 Nov 2020 is uploaded on DESA website.

3. A large number of cases are received at DESA, wherein post the demise of the veteran, widows find it difficult to get the pension. The reason could be as simple as mismatch of name/ date of birth in PPO and PAN card or even sometimes the name is not included in the PPO. Same is the case for eligible children. All veterans are requested to check for the following, and take corrective action, if required :-

- (a) Name of spouse is included in PPO along with her date of birth.
- (b) Name and Date of Birth of spouse in PPO is same as that in PAN and Aadhar card.
- (c) Pension account is a joint account between pensioner and spouse.
- (d) Dependent Identity card for spouse and dependents is made from respective Zila Sainik Board.
- (e) Particulars of children are updated in record office.
- (f) Maintain a file with all important documents and ensure that spouse/ family members are aware of its location and particulars.

4. Check off lists and forms for various contingencies are available on DESA website.

5. **Articles for NWWA E-Chronicles**. To encourage creative writing skills of our naval Community, an online magazine – ‘**NWWA e-Chronicles**’ has been started which is posted on the NWWA website. NWWA letter NWWA/71/E-Vir-21(ii) in this regard has been uploaded on DESA website.

6. **28th AGM**. The 28th AGM of Navy Foundation was held through Video Conference on 29 Jan 21. Minutes of Meeting of 28th AGM have been uploaded on DESA website.

7. Navy Foundation Pune Chapter(NFPC) organized an AGM and Admiral J G Nandkarni Memorial lecture – 2021 in Central Park Hotel, Pune on 03 Oct 21. NFPC is fortunate to be first chapter to host interactive session post Covid -19 pandemic. AGM was conducted in two session. The forenoon session of AGM was dedicated towards Admiral J G Nandkarni Memorial lecture – 2021. In afternoon session, presentation by PCDA (N) reps on ePPO and interactive session by OiC NAVPEN and NAVPEN reps was well appreciated by veterans present.

8. All the retirees post Oct 2017 are automatically members of VSF. They have been clubbed into VSF groups on WhatsApp. All important information wrt ESMs including various job opportunities are being regularly disseminated through these WhatsApp groups and also as also through DESA and INPA websites. Personnel who are not added into any of the VSF groups may contact us on 011-26881019.

Grants to Retired Naval Personnel and Their Families

9. **INBA Scholarship Scheme.** INBA scholarship forms are available on Indian Navy website. They are to be duly filled and counter signed by Zila Sainik Board/VSF before submission to INBA.

10. **Merit Scholarship.** Merit Scholarship from INBA is provided to children in advance for pursuing graduation and post-graduation degree courses and also for vocational courses in recognized polytechnics institutions of 50 weeks or more duration. Application for award of fresh/ renewal of scholarship duly completed in all respects along with requisite documents is to be forwarded to INBA by 01 Nov every year through ZSB (for ESM) and through CRSOs (for widows) at dnpf@navy.gov.in. DNPF may be contacted on tele 011-21410785. Details are available at www.indiannavy.nic.in. Eligibility conditions for scholarship is as follows:-

- (a) Only first two children irrespective of number of children in family.
- (b) Children pursuing post 10+2 recognized courses.
- (c) Children who pass all subjects in first regular attempt.
- (d) Children who take admission within two years of passing 10+2 or graduation as the case may be.
- (e) Scholarship not availed during any year for any reason what-so-ever cannot be made good in subsequent years.
- (f) Scholarship are awarded each year on this basis of percentage of marks obtained in the last qualifying exam.
- (g) Renewal of scholarship is done on receipt of application each year in time provided the specified conditions/percentage criteria is met by the child.
- (h) When a candidate is in receipt of assistance from Government/ Educational institutions or any other private source, the quantum of scholarship will be restricted to the difference between the amount being received and that which would normally

have been given by INBA. In case assistance from other sources is higher the child will not be eligible for INBA scholarship.

9. **Felicitation of Senior Veterans on the Occasion of 75TH Year of Independence.**

Special felicitation of Veterans born in or before 1947 was conducted at Eastern Naval Command on 15 Aug 21 to commemorate the 75th Anniversary of Independence. The Commemorative events were conducted at Parade Ground, Circars and HQENC lawns. Photographs of FOC-in-C felicitating the Veterans during the Independence Day celebrations are uploaded on the DESA website.

10. **Sponsorship Scheme to Join Indian Navy as Sailor.** Naval personnel (serving/ retired) and widows of Naval personnel who died whilst in service/ after retirement, may sponsor one candidate per batch for recruitment as a sailor. IHQ MoD(N) letter [NR/0101/03/RECT/POLICY dated 01 Jun 17](#) has been posted on DESA website. Procedure for recruitment of sponsored candidates is as follows :-

(a) **Categories of Sponsored Candidate.** The categories of Naval personnel whose sons are eligible for sponsorship scheme in decreasing order of benefits are as follows:-

- (i) Battle Casualty/ Accident.
- (ii) Died whilst in service.
- (iii) In service.
- (iv) Retired/ Died after retirement.

(b) **Battle Casualties/ Accidents.** Sons of Naval personnel under battle casualties/ battle accidents/ sea/ air raid casualties who satisfy all eligibility conditions may be given instant enrolment as SSR/MR. The candidate is required to fulfil minimum educational qualification for respective entry. They will be enrolled without appearing in the examination provided they qualify PFT and medical examination. Such candidates will be also be entitled for relaxation in age up to 12 months.

(c) **Died whilst in Service.** The sons of Naval personnel who died whilst in service may be sponsored by the widow of the naval personnel. Such candidates will also be entitled for relaxation in age up to 12 months. Special relaxations for sons of Naval personnel who died whilst in service are as follows:-

- (i) **SSR Entry.** Sons of Naval personnel (who die whilst in service), with 50% or above marks in 10+2/ equivalent with Physics and Maths and at least one of the optional subject of Chemistry/ Biology/ Computer Science will be enrolled without appearing in the examination provided they qualify the PFT and medical examination. However, candidates with below 50% marks in

10+2/ equivalent with Physics and Maths and at least one of the optional subject of Chemistry/ Biology/ Computer Science will have to appear and pass the written examination, PFT and medical examination. He will be awarded additional 08 marks above those obtained in the written examination. Alternatively, such candidates will have the option of applying for MR.

(ii) **MR Entry**. Sons of Naval personnel (who die whilst in service), who have passed 10+2 / equivalent with Physics and Maths and at least one of the optional subject of Chemistry/ Biology/ Computer Science with less than with 50% marks or who have passed in Matric/ equivalent with more than 50% marks, will be enrolled directly as MR (Chef/ Steward/ Hygienist) without appearing of the examination, provided they qualify the PFT and medical examination. However, candidates with below 50% marks in 10+2/ equivalent will have to appear and pass the written, PFT and medical examination. He will be awarded additional 08 marks above those obtained in the written examination.

(d) **In Service**. Sons of serving Naval personnel, who have qualified 10+2 or equivalent with Physics & Mathematics and at least one of the optional subject of Chemistry/ Biology/ Computer Science are eligible for SSR entry. They will be called to appear for written examination irrespective of qualifying cut off percentage of the respective State. Such candidates will also be entitled for examination in age up to 06 months and will be awarded additional 05 marks above those obtained in the written examination.


(e) **Retired/ Died after Retirement**. Sons of Naval personnel (retired/ died after retirement), who have qualified 10+2 or equivalent with Physics & Mathematics and at least one of the optional subject of Chemistry/ Biology/ Computer Science are eligible for SSR entry. They will be called to appear for written examination irrespective of qualifying cut off percentage of the respective State. Such candidates will also be entitled for relaxation in age up to 04 months and will be awarded additional 05 marks above those obtained in the written examination.

11. **Sponsorship Form**. The Sponsorship form is to be uploaded online. The Sponsorship form is to be countersigned by the Commanding Officer (for Serving Naval Personnel) or Secretary Zila Sainik Board/ DESA/ CRSO (for others). Certificate 'To Whom-so-Ever It May Concern' instead of Sponsorship Form will not be acceptable.

12. **11th GCM/AGM of Veteran Sailors' Forum.** RGC North AGM of VSF was scheduled on 05 Apr 20 at Delhi. In view of the restrictions improved for COVID-19 the Annual General Body Meeting is yet to be conducted. Dates will be promulgated as and when the situation improves.

13. **Membership – Navy Foundation and Veteran Sailors' Forum.** Navy Foundation and Veteran Sailors' Forum meetings cover a large number of issues. In addition to the veterans, a large number of senior serving officers attend these meetings to resolve the issues being faced by veterans. These meetings, therefore, serve as an important link and channel of communication between the retired and the serving. During the 11th VSF GCM it was decided to increase the membership of VSF Members. It is therefore, requested non-member naval ESMs be encouraged to become members of the VSF as also that of NF.

14. **MoU with Flipkart.** Memorandum of Understanding for employment of retired/retiring personnel has been concluded with Flipkart on 15 Sep 21. The MoU would facilitate employment of retiring/ retired personnel across the length and breadth of the country in all Flipkart Mother hubs/ corporate offices. IHQMoD(N)/ DESA letter DX/300/INPA dated 15 Sep 21 has been uploaded on DESA website.
15. **Reservation for Ex-Servicemen in Assam Rifles and CAPFs.** Assam Rifles letter I.11011/ESM/Rect Branch/ 2021/170 dated 18 Feb 2021 has been uploaded on the DESA website.

17. **ECHS Application Verification for Sailors.** ECHS application verification of sailors for 64 KB card are undertaken at NAVPEN being the Record office. The applicants may contact 022-2575619 for guidance.
18. **Reimbursement of Medicines – Special Sanction in view of COVID-19.** Central Organisation, ECHS letter B/49761/AG/ECHS dated 16 Apr 21 has been uploaded on DESA website.
19. **ECHS Advisory Self Uploading of Claims by Veterans.** ECHS letter B/ 49769 /AG/ECHS dated 23 Aug 2021 regarding ECHS advisory and reimbursement module for self-uploading of claims by Veterans has been uploaded on DESA Website.
20. **Transfer of Cards Between Polyclinics.** ECHS beneficiaries at present receive their smart cards at their Parent Polyclinics. However, in certain cases the ESM/Beneficiary may have relocated himself/herself and require cards to be sent to another Polyclinic. In order to facilitate the same, a software module has been implemented to assist transfer of new 64kb ECHS cards from one Polyclinic to another. (Auth:- Central Organisation ECHS letter No. B/49711-NSC/AG/ECHS dated 28 Jun 2021)
21. **Referral Procedure to Empanelled Hospitals for ECHS Beneficiaries.** ECHS beneficiaries are provided medical cover through a network of Regional Centres, polyclinics and civil hospitals empanelled with ECHS. Any specialized treatment required by the beneficiary are referred to Military Hospitals or Empanelled Hospitals in the Area of Responsibility of the parent polyclinic. The policy has been revised to bring flexibility in the referral policy of ECHS, wherein, beneficiaries can now avail referral to Military Hospital/

empanelled hospitals outside the Area of Responsibility of the Parent Polyclinic. (**Auth:-** Central Organisation ECHS letter No. B/49711-NSC/AG/ECHS dated 15 Jul 2021)

22. Blocking of Cards in Case of Ineligibility/Demise and Disciplinary Reasons. ECHS cards are required to be blocked on occasions such as demise of an ECHS beneficiary or cessation of eligibility/ disciplinary grounds when ordered by Competent Authority. The provision for blocking of cards has been provided on ECHS website/portal and can be undertaken by the beneficiary and OIC Polyclinic as the case may be.

23. Utilisation of ECHS Services Validity of ECHS Cards & Temporary Slips. 16kb ECHS Cards and offline temporary slips are no more valid w.e.f 01 Apr 2021. A guest user module has been implemented at all Polyclinics to enable 16kb ECHS Card holders and offline temporary slip holders to apply for new 64kb ECHS Cards at polyclinics. This guest user module can also be utilized for generation of Temporary Slip (validity : 30 days) to provide medical cover to the beneficiaries.

24. Amendment for Reimbursement of Medicines: Special Sanction in view of COVID-19. A onetime sanction for purchase of medicines and claim re-imbursement was earlier issued till 31 Jul 2021. In order to promote social distancing and avoiding unnecessary exposure to the veterans as well as minimizing footfall at Polyclinics, ECHS beneficiaries having life style/chronic ailments/ disease on long treatment may purchase medicines lasting till 31 Oct 21 in one go based on prescription held irrespective of non-availability of medicine.

25. Provision of Guest User at ECHS Polyclinics. Central Organisation ECHS letter No. B/49711-NSC/AG/ECHS/Guest User dated 13 May 2021 has been uploaded on DESA website.

26. Claiming of Medical Bills for Symptomatic COVID-19 ECHS Beneficiaries who are RT PCR/ RAT Negative. Claims for re-imbursement under this category will be reimbursed as per the State notified rates for treatment of COVID – 19. Central Organisation, ECHS letter B/49761/AG/ECHS dated 06 May 21 has been uploaded on DESA Website.

27. Guidelines for Claiming Reimbursement of Home Isolation Service Package-COVID 19. Central Organisation, ECHS letter B/49761/AG/ECHS dated 30 Apr 21 has been uploaded on DESA Website.

28. **White Cards**. As per existing provisions, White Card holders are given priority treatment at all ECHS polyclinics, from reception to attendance by doctors and for issue of medicines. The following are eligible for white cards:-

- (a) War Disabled/ Battle Casualty Veterans.
- (b) Spouses of War Disabled/ Battle Casualty Veterans.

29. **Treatment under AYUSH**. Govt. has authorised treatment under AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homeopathy) for all ECHS beneficiaries. Treatment in Govt. AYUSH hospitals is permitted on reimbursement basis at full rates, including the cost of prescribed medicines. For treatment under the scheme prior permission of Oi/C of the Polyclinic or Director, Regional Centre or CO ECHS, for a particular disease is to be obtained. It may please be noted that only one system of treatment is allowed at any point in time.

30. **ECHS Application for Android App**. ECHS has launched an Android based application for beneficiaries and this app is available on the Google Play Store for free download. Various facilities such as status of application, booking of appointment with the doctor, medical history of the patient, contacting the doctor in an emergency etc. have been made available in the application.

31. **Priority for Elderly ECHS Patients**. ECHS beneficiaries above 75 years of age can visit specialist OPDs at Military hospitals directly (on OPD days), without obtaining referral from ECHS polyclinics.

32. **Actions in Case of 'Forgot Password'**. A number of veterans tend to forget passwords, which they have created for 'logging-in' to the ECHS website during the process of online registration. Earlier, there was no facility to retrieve/ reset it. A system has now been instituted, wherein by sending an email (with minor details like Name, Number, etc) from the registered email id, the password can be reset by the beneficiary.

33. **Handing Over of ECHS Smart Cards to ECHS Beneficiaries**. Central Organisation, ECHS letter No. B/49711-IT/AG/ECHS/Gen Corr dated 11 Nov 20 & B/49711-IT/AG/ECHS/Gen Corr dated 11 Mar 21 has been uploaded on DESA Website.

34. **Grant of ECHS Facilities to SSCOs and Non Pensioner Pre-Mature Retirees and their Spouses**. ECHS facilities have been granted to SSCOs/ Non Pensioner Pre-Mature Retirees. They must pay for OPD/ IPD/ Investigations in ECHS empanelled hospitals and seek reimbursement @ 75% of total admissible expenditure for personnel having more than 10 years of service and @ 50% of total admissible expenditure for personnel having less than or equal to 10 years of service respectively. They will have to make full payment first to the empanelled hospitals and then claim laid down percentage from ECHS on reimbursement

basis as per CGHS rates. Claims will need to be submitted to parent ECHS Polyclinic with claim marked in bold red 'Reimbursement Claim – Non Pensioner (SSCOs/ PMR)'. They can utilize non empanelled hospitals in emergency as per norms applicable to other ECHS members. The applicant must register under the category of SSCOs retiree at www.echs.gov.in.

35. **Grant of ECHS Membership to the Ex-sailors appointed prior 03.07.1976 and Discharged on or after 03.07.1976 on Expiry of 10 Years of Service.** DESW has agreed to categorise the ex-sailors, who meet the twin conditions for getting membership of ECHS, as "Normal Pension drawing ECHS beneficiaries".

36. **Empanelment of Hospitals / Nursing Homes and Diagnostic Centres for ECHS.** 150 Hospitals / Nursing Homes and Diagnostic Centres for ECHS are empanelled across the country vide Gol letter No. 22B(01)/2020/WE/D(Res-1) dated 24 Feb 20. This letter is available in public domain and is available on DESA website.

37. **Important ECHS Website & E-mails.** Following website/ email addresses can be used for guidance by veterans for issues related to ECHS :-

38. **Extension of ECHS Facilities.** The Government has extended ECHS facilities to the following: -

- (a) Pensioners of Assam Rifles.
- (b) World War II Veterans, Emergency Commissioned Officers, Short Service Commissioned Officers and also premature retirees, although all of them are non-pensioners. It may be noted that the facility has been extended only to their spouses and not to other dependents.

39. **Amendment to Provisions Regarding Supply of Medicines to ECHS Beneficiaries.** Gol, MoD has sanctioned reimbursement of medicines and consumables to ECHS beneficiaries for a maximum period of 15 days at a time, subject to maximum value of medicines and consumables not exceeding Rs. 25,000/- each time under

general conditions and 30 days at a time subject to maximum value of medicines and consumables not exceeding Rs. 75,000/- each time (Rs 2, 00,000/- for cancer drugs) under special conditions. This would be subject to obtaining NAC from OIC ECHS Polyclinic.

40. **Treatment of Senior Citizens.** ECHS beneficiaries of undermentioned ages will continue to be given priority for medical attendance at Polyclinic including consultation, check-up and issue of medicine.

Department of Ex-Servicemen Welfare(DESW), Ministry of Defence vide letter No 6(1)/2017/D(Res-11) dated 21 May 18 has made the provision of five percent reservation for admission of wards of Ex-Servicemen in professional/medical/Non- professional courses in the Govt colleges/

- Priority VI : Wards of Ex-Servicemen.

 - (ii) Defence personnel disabled in service and boarded out with disability attributable to military service.
 - (iii) Ex-Servicemen and serving personnel who are in receipt of Gallantry Awards.
- Priority VIII : Wards of Serving Personnel.

Pension Related Issues

60. Grant of Terminal Benefits, Family Pension and gratuity to eligible Member of the Family of Naval Personnel/ Pensioner/ Family Pensioner Reported Missing.

Gol MoD has over a period of time promulgated methodology for grant of terminal and other pensionary benefits to the families of service Personnel who disappear while in operational and non-operational service and whose whereabouts are not known. It includes those kidnapped by insurgents/terrorists but does not include those who disappear after frauds/crime/desertion etc. DPA letter PN/0725/Missing Personnel/Policy/21 has been uploaded on DESA website.

61. Regular Retiree ePPO. Sailors released on Expiry of Engagement (EOE) have been issued ePPO by PCDA Navy commencing Jan 2021. The CPPC (Bank) copies are transmitted online by PCDA Navy to CPPC. The individual copies are uploaded on NAVPEN website for the pensioner to download their ePPO copy.

62. Amendment of Income Criteria for Grant of Family Pension to Children/ Siblings Suffering from Mental or Physical Disability.

DoP&PW vide their OM No 1/17/2019-P&PW(E)dated 08 Feb 21 has indicated that a child/ sibling of a deceased Govt servant/ pensioner, who is suffering from a mental or physical disability, shall be eligible for family pension for life, if the appointing authority is satisfied that the disability is of such a nature so as to prevent him/her from earning his/her livelihood, as evidence by a disability certificate obtained from a competent authority. Gol MoD letter F.No.1 (7)/2013/D(P/P)/Vol-I dated 28 Sep 21 has been uploaded on DESA website.

63. System for Pension Administration Raksha (SPARSH).

(a) Pension processing for naval personnel have been shifted from PCDA (N), Mumbai to SPARSH from Jun 21 from sailors and from Jul 21 for Officers.

(b) PCDA (Pension), Allahabad issues Pension and remits the pension and Gratuity to the pensioner bank account in SPARSH.

(c) The role of CPPC of Banks have been done away in SPARSH.

(d) Pensioners may approach PCDA (Pension), Allahabad post issue of PPO for any pension issues on Toll Free No 1800 1805 325 or lodge a complaint on sparsh.defencepension.gov.in.

64. **Sailors Pre 2016 ePPO Spouse Date of Birth.** NAVPEN have provided Spouse Date of Birth of 35,000 sailors to PCDA(N), Mumbai from the records held in NAVPEN based on the Kindered Roll submitted by the ex-sailor during their service time. This is to facilitate reflecting correct DOB of Spouse in the Notional Pay Fixation PPO for Pre 2016 released sailors, being issued in ePPO form. PCDA(N) will be generating ePPO with this Spouse DOB and the same will be uploaded on NAVPEN website as and when provided by PCDA Navy. The CPPC (Bank) copy of ePPO will be transmitted by PCDA(N) online.

65. **Streamlining of Pension Payment Procedure – First Identification of Pensioner for Release of Pensionary Awards.** IHQMoD(N)/ DPA letter PN/0725/21 dated 09 Jul 21 has been uploaded on DESA website.

66. **Option for Fixation of Pay on Promotion from the Date of Next Increment (DNI) on Grant of MACP (Mechanism iro Sailors Released from 01 Jan 16 to 31 Jul 21).** As one-time exercise following actions are to be carried out for the sailors released from 01 Jan 16 to 31 Jul 21 (DPA letter PA/6313 dated 02 Jul 21 is uploaded on DESA website):-

- (e) **Issuance of BOIC.** CABS is to forward BOIC issued for grant of MACP iro Sailors released from 01 Jan 16 to 31 Jul 21, to NPO by 30 Sep 21.
- (ii) **Fixation of Pay** NPO is to fix pay using best option for the released sailor, suo-moto quoting this policy letter as authority, by 31 Mar 22 view following:-
 - (aa) Data for calculating best option is of historical nature and is available with NPO. Thus NPO will be able to calculate best option for all individuals.
 - (ab) Difficult to reach and obtain option form from each and every released personnel.
 - (ac) View ongoing COVID restrictions, mail management is not fully functional on a pan India basis.

67. **Know your Pension Payment Order (PPO).**

- (a) Check correctness of “Name” of self and spouse.
- (b) Check correctness and full “Date of Birth” of self and spouse are mentioned in the PPO.
- (c) Check correctness of “Rank” indicated in the PPO.

- (d) Check correctness of “Bank details” (Account No. and Branch address).
- (e) Original copy of PPO to be kept safely.

68. Digital Life Certificate for pensioner’s scheme of the GoI, known as **Jeevan Pramaan**, seeks to address the requirement of personally being present in front of the disbursing agency by digitising the whole process of securing the life certificate. It aims to streamline the process of getting this certificate and making it trouble free and easier for our pensioners. The steps to be followed by the pensioners to generate Life Certificate are given below:-

- (a) **Step 1.** Download mobile app. Alternatively, visit nearest Jeevan Pramaan Centre to get registered. Provide necessary information like Aadhar No, PPO No, Bank Account No, Bank name and Mobile No.
- (b) **Step 2.** Provide your biometrics, either a finger print or Iris scan and authenticate yourself.
- (c) **Step 3.** After successful authentication a SMS acknowledgement is sent to your mobile no, including your Jeevan Pramaan certificate ID. The certificate is stored in the Life Certificate Repository and is available anytime and anywhere.
- (d) **Step 4.** You can download a *pdf* copy of the certificate from the Jeevan Pramaan website by providing the Jeevan Pramaan ID.
- (e) **Step 5.** The Pension Disbursing Agency can access the life certificate from the Jeevan Pramaan website and download the same.

69. **Extension of Period for Submission of Life Certificate from October 2020 till December 2020.** Ministry of Personnel, Public Grievances & Pension, Department of Pension & Pensioner’s Welfare letter dated 11 Sep 20 is available on the DESA website.

70. **Issuance of E-PPO for Pre-16 Pensioners/ Family Pensioners**

- (a) PCDA(N) Mumbai has commenced generation of e-PPOs in respect of Retd officers/ Ex-sailors, who retired or were released from service between 01 Nov 1985 and 31 Dec 2015. The e-PPOs generated and issued by PCDA (N), Mumbai have been uploaded on the NAVPEN website, accessible through link https://www.indiannavy.nic.in/navpen/eppo_download.
- (b) PCDA(N) Mumbai is still in the process of generating e-PPOs in a progressive manner. The e-PPOs generated will be uploaded on the NAVPEN website as and

when received from PCDA(N) Mumbai. A list of Service Numbers whose Pre-2016 e-PPOS have been uploaded on the website can also be viewed at <https://www.indiannavy.nic.in/navpen/list-pre-2016-e-ppos-generated>. Individuals may check for the service No (Without Service Alphabet) available in the list (both Retd Officers & Ex-Sailors) from the mentioned link which will be updated from time to time. Further, individual whose service No. is included in the list may go to the link https://www.indiannavy.nic.in/navpen/eppo_download and download the e-PPOs by entering the Service No.(including suffix Alphabet) and Date of Birth in the format provided.

(c) In case of any clarification and discrepancy/ error observed in the e-PPO, the pensioner are requested to seek clarification from PCDA(N) Mumbai on e-mail ID pcdanavysuomoto.dad@gov.in.

71. **Check-off List for Pension Related other Issues**. Latest check list required for processing grant of dependent family pension/ endorsement of name/ date of birth etc and various draft letters are available on DESA website.

72. **Special Drive for Notification of Marriage in Service Records and Endorsement of Name for Grant of Family Pension in Service Pension Payment Order of Retired ESMs**. Gol letter (Department of Ex-Servicemen Welfare) 345/DS/PG/SM/2020 dated 03 Aug 20 is available on the DESA website.

73. **Accident Insurance Cover Applicable to Indian Navy Personnel Holding DSP Account in SBI**. SBI letter DBA/NAVY/09 dated 21 Jan 20 is available on the DESA website.

74. **Customisation of NAVPEN Website for User Friendly Access of Data for Veterans**. NAVPEN website, <https://www.indiannavy.nic.in/navpen> is a microsite of Navy website on open domain (i.e internet) for use by all veterans.
