**GRANT OF EDUCATION CONCESSION TO THE CHILDREN OF
OFFICERS/SAILORS MISSING/DISABLED/KILLED IN ACTION**

1. Refer to GoI, MoD letters No. 6(1)/2009/Edu. Concession/D(Res-II) dated 13 Sep 17 and 23 Mar 18.
2. The Govt of India has granted Education Concession to the children of those Officers and Sailors who are missing/disabled/killed in action, vide GOI letter ibid. The Education Concession admissible towards the expenditure incurred on children of these category of personnel will consist of the following:-

(a) **Tuition Fees.** Full reimbursement of tuition fee (Capitation fee and Caution money not included) levied by the Educational Institutions concerned (including charges levied for the school bus maintained by the school or actual fares paid for railway pass for students or bus fare certified by the Head of Institutes).

(b) Hostel Charges. Full reimbursement of Hostel charges for those studying in boarding schools and colleges.

(c) Cost of Books/ Stationery. Rs 2,000/- (Rupees two thousand only) per annum per student or the amount claimed by the student, whichever is less.

(d) Cost of Uniform where uniform is Compulsory. Rs 2,000/- (Rupees two thousand only) per annum per student or the amount claimed by the student, whichever is less.

(e) Clothing. Rs 700/- (Rupees seven hundred only) per annum per student or the amount claimed by the student, whichever is less.

3. The Concessions shall go up by 25 percent each time DA rises by 50 percent.

4. The Education Concessions referred to above will be admissible only for undertaking studies in Govt./ Govt Aided schools/ Educational Institutes, Military/ Sainik Schools and other schools or colleges recognised by the Central or State Governments including the autonomous organisations financed entirely by the Central/ State Governments.

5. The above Education Concession will be available to school going children from 02 classes prior to 1st class upto and inclusive of First Degree Course.

6. Reimbursement of Education Concession shall have no linkage with the performance of the child in his/her class. In other words, even if a child fails in a particulars class, the re-Imbursement of the said concessions shall not be stopped.

7. The entitled personnel or their NOK to submit following documents (in triplicate) to respective Zila Sainik Board for scrutiny, countersignature and onward despatch to Naval Pay Office :-

(a) Certificate for re-imbursement of Children Education Concession in respect of Officers/Sailors missing/disabled/killed in action (Format placed at Enclosure-I).

(b) Payment Voucher for Re-imbursement of Children Education Concession in respect of Officers/Sailors missing/disabled/killed in action (Format placed at Enclosure-II).

(c) Original receipts of Fee/other expenditure incurred.


(d) Copy of Document/Certificate stating that father/mother of the child was Missing/ Disabled/Killed in action.

(e) Copy of Battle Casualty Certificate, if applicable.

(f) Copy of PPO.

8. Naval Pay Office is to issue Payment Authority and credit the same in the account of eligible personnel.

9. The Education concession referred to in this order will be debitable from Major Head 2077 and Minor Head 101.
10. These orders shall be effective from 01 Jul 17.
11. It is requested that contents of the letter may be given wide publicity.
