

PILOT PROJ : KSB AND OLA SKILLING WITH ESM

1. It is intimated that KSB, an apex body for welfare of ESM of Tri-services is in talks with Ola skilling for providing a micro-entrepreneurship platform to the ESM (incl their eligible wards). It has been decided to start a pilot proj at Delhi-NCR initially, before signing a detailed MoU between both the organizations for pan India application. This will go a long way in affording a decent second career and enabling the ESM a respectable livelihood in close proximity to their chosen place of resettlement.

2. **Ola Skilling Proposal.** The draft proposal recd from Ola is as under :

- (a) Offering ex-servicemen livelihood at location of their preference.
- (b) Creating a customized training program for ex-servicemen. Ola would also waive off the entire cost of training program to ex-servicemen.
- (c) Set up an exclusive counseling and partner support team for ex-servicemen drivers' queries and concerns.

3. **General Leasing Scheme Summary.** Initial investment for the car is made by Ola Fleet Technologies (OFT); regular car maintenance and insurance costs are to be taken care of by OFT. Driver earnings are based on actual login hours and trips completed and bears the lease payments along with fuel expenses. Driver has the option to buy back the car at the end of the lease period at 10% of the vehicle cost. The leased vehicle shall be for use only on OFT platform and not for personal use. Daily rental of the vehicle selected would be charged to the partner, which would be deducted from his account. Car Repair & Maintenance (as per policy) would be undertaken by OFT itself. Four days of lease pause (non-working days) per month has been considered.

4. **Eligibility Criteria.**

- (a) Education - Minimum 8th standard pass.
- (b) Ex-servicemen should have valid Light Commercial Vehicle (LCV) or Light Motor Vehicle (LMV) license. Dvr trade is not a essential pre-requisite.
- (c) They should pass the initial verification i.e., Police verification, etc. This will be jointly facilitated by KSB and Ola Skilling.

5. **Initial Verification.** Fwg documents are required to be submitted by the ESM -

- (a) Minimum 8th class pass school certificate.
- (b) Discharge Cert, PPO and ESM ID Card.
- (c) PAN card and Aadhaar card.
- (d) Permanent address proof.
- (e) Passport size photographs.
- (f) Passbook/cancelled cheque leaf for bank details.
- (g) Valid Driving License issued by RTO (LCV/LMV).

6. **Veh Security Deposit.** (When veh is being provided by Ola).

- (a) Eligible candidates have to pay a Security deposit amount which varies as per city and model of car being used.
- (b) The amount varies from Rs 11,000/- for refurbished Hatchback model like Beat or Indica to Rs 36,000/- for new sedans like Maruti Swift Dzire and Hyundai Xcent.
- (c) The security deposit amount is partially refundable when a driver partner leaves as per company policy after deduction of pending dues and damages to the vehicle, if any.

7. **Placement Location.** For pilot proj, only Delhi-NCR is being offered.

8. **Earning Potential.**

- (a) Earning potential at Delhi-NCR will be between Rs 30,000/- to Rs 35,000/- for self car owner depending on the type of car and between Rs 20,000/- to Rs 23,000/- for Ola provided veh.

(b) Constraints. A driver partner has to log in the Ola driver app for minimum 11 hours daily for 26 days in a month and minimum 12 hours daily for 26 days in a month for non-CNG cities.

9. Insurance Cover. An insurance cover of Rs 2 Lacs for each dvr will be done by Ola.

10. In view of The above, KSB requests the IESL to provide all help and assistance as this pilot project will benefit all veterans as it is estimated that the proj is likely to generate employment for nearly one lakh ESM and their wards in next one yr and approx five lakhs in next two yrs.
